All materials over 300mm in diameter to be supplied by the lessee or developer (as applicable). Site specific conditions should be considered for both the site under development and any site Icon Water will need to enter to undertake the work. Failure to identify induction or documentation requirements may delay work and add further cost for which the lessee/developer will be responsible.

Conditions of quotation

This form is to be used when requesting quotes in respect of non-contestable hydraulic work. This is work that must be undertaken by Icon Water, or its authorised contractors or agents, on mains owned by Icon Water and includes water main connections and shuts, hydrants and sewer main connections.

All quotations are for basic installations only and are valid for three months only from the date of issue. Quotes are based on the approved drawings, scope of works and information outlined in this *Request for quotation for non-contestable hydraulic works* form and, if applicable, a site visit by Icon Water.

Icon Water reserves the right to charge additional costs on a reasonable cost-plus basis if:

- the scope of works changes
- unexpected site or latent conditions are encountered
- the works include non-standard components
- the work is of an unusual complexity
- works outside normal working hours are required
- works are not ready to proceed when Icon Water arrives on site
- information included in this form is incomplete, inaccurate or changes prior to commencement of the works
- there is a change in any laws relating to the works.

Icon Water will endeavour to carry out the works within 10 business days of payment of the quotation subject to:

- inspection and testing to Icon Water satisfaction
- submission and acceptance by Icon Water of a connection/disconnection plan (External Services Plan) drawings
- the lessee or developer being ready to proceed
- availability of materials
- operational constraints.

It is the responsibility of the lessee or developer (as applicable) to meet the cost of Icon Water charges together with all internal or external works which may be necessary to carry out a connection or disconnection to the Icon Water network including:

- preparation of the site
- excavation
- backfilling
- reinstatement (restoration)
- road opening and traffic permits

- traffic management
- supplying a machine to lift and push on-fittings on mains greater than 150mm in diameter.

Water meters must be installed prior to connection. Existing water meters may only be removed by Icon Water personnel. Removal of water meters by non-Icon Water persons is unlawful and the owner of the property and/or builder may be subject to legal action, meter replacement or placement costs, reimbursements for water use and other associated costs. Existing meters are to be barricaded and protected from damage at all times during the construction and demolition process. Water meters must be accessible for reading at all times.

Where a lessee or developer (or their employee, contractor, consultant or agent) cause damage to Icon Water's network, including actions that lead to a blockage in the sewerage system, the lessee or developer must reimburse Icon Water for the costs to rectify that damage.

Employees, contractors, consultants or authorised agents of Icon Water are the only persons permitted to work on, cut or tap into Icon Water's mains unless otherwise authorised in writing by Icon Water. All other work is contestable and when approved by Icon Water, can be carried out by licensed trades persons. Icon Water will prepare a quotation for contestable works if requested.

Quotations pursuant to this form cover work that must be undertaken by Icon Water on mains owned by Icon Water. Quotations will include preparatory tasks related to the water and sewerage networks such as notification of customers and shut down of the network. Icon Water will provide 10 days written notice of the access requirements to undertake the works.

Acceptance of the quotation in writing shall indicate your acceptance of the conditions in this form. Once written acceptance has been received by Icon Water it will invoice the lessee or developer (as applicable).

Additional conditions for water main shut

A minimum of seven days notice is required for a water main shut to allow for customer notifications and to ensure crews are available to carry out the shut unless otherwise agreed in writing by Icon Water.

Fees for water main shuts are dependent on the complexity of the shut, the need for customer notification and for crews to Although work crews will endeavor to carry out valve remain on site and the timing of works e.g. after hours or operations at agreed times, actual timing is subject to weekend.

Operational requirements

Payment of fees does not guarantee that the shut can be carried out. If valves cannot be located or are not operational the shut may be delayed or postponed.
